SEPTEMBER 5, 2006 - SAMPLE BALLOT

All registered voters in Volusia County are eligible to vote in this Primary!

Democrats will be able to cast their ballot for Democratic and Nonpartisan races for the districts in which they live.

Republicans will be able to cast their ballot for Republican and Nonpartisan races for the districts in which they live.

All others who are registered with a minor party affiliation or with no party affiliation (NPA) will be able to cast their ballot for Nonpartisan races for the districts in which they live.

Residents of the City of Daytona Beach Shores and the City of Oak Hill residing within the city limits, no matter what their party affiliation, will also be able to vote on municipal candidates and questions appearing on their ballots.

Photo and Signature Identification

Requirements

Prior to voting, the voter shall be required to present one of the following current and valid picture identifications listed below. If the picture identification does not contain the signature of the voter, an additional identification that provides the voter's signature shall be required. If the voter fails to furnish the required identification, he or she shall be allowed to vote a provisional ballot.

Your voter information card is no longer a required form of identification to use at the polls, but a very helpful resource to be used as it contains your name and residence address as it appears on the registration rolls, as well as your precinct number and the districts in which you are eligible to vote.
